

## Heller Board of Advisors 2022-2023 Biographies



**CONSTANCE KANE, PhD'85, (CHAIR)** has had a lengthy career in international social justice and human rights. She is currently the Executive Director at Empowered to Educate, where their mission is to empower women with resources and support to become leaders and innovators of education. She was previously the Executive Director of the Relational Diplomacy Institute (RDI) in Boston where she directed the Women Changemaker's in Education Awards. These Awards recognize the contributions of rising female educators throughout the world. Prior to RDI, she worked for the Unitarian Universalist Service Committee as the Vice President and Chief Operating Officer. She has also served in senior management positions in the Africa Division of World Education, Boston; Pact, Inc.; and Oxfam America, Boston. Previously, she lived and worked on sustainable development and reducing global poverty projects in Japan, Indonesia, and Malaysia. She also lived for three years in Cairo, Egypt, where she completed her doctoral-degree research by comparing Egypt and Israel in their methods of social-service delivery. She is a graduate of Western College in Oxford, Ohio, and has a master's degree in social planning from Boston College and a PhD in social welfare policy from the Heller School at Brandeis University in Waltham, Mass.



**MICHAEL S. JELLINEK, M.D., (VICE CHAIR)**, earned his undergraduate degree at Columbia College and his medical degree from the Albert Einstein College of Medicine in Bronx, New York, completed pediatrics training at Montefiore Hospital and Medical Center, Bronx, NY, and residencies in child psychiatry at Children's Hospital Medical Center in Boston, MA, and in psychiatry at Massachusetts General Hospital, also in Boston. Currently he is Professor Emeritus of Psychiatry and of Pediatrics at Harvard Medical School.

Dr. Jellinek was Chief of Child Psychiatry at Massachusetts General Hospital for 32 years from 1979- 2012. Dr. Jellinek has written or co-written over 300 original reports, articles, and chapters, and served as Editor for the AAP of Bright Futures in Practice: Mental Health. With Michael Murphy, Ed.D., he developed the Pediatric Symptom Checklist, which is a widely used brief screening instrument that has been validated to help primary care pediatricians identify children with emotional problems.

Dr. Jellinek has served in several administrative positions including Senior Vice President for Administration at Massachusetts General Hospital (1996-2000), President, Newton Wellesley Hospital, Newton, MA, (2001-2012), as Chief Clinical Officer, Partners HealthCare (2012-2014), and CEO, Community Network and EVP, Lahey Health System (2014-2016). Currently he practices as a psychiatrist, teaches at MGH, and is a management consultant (Ulysses Consulting). At Brandeis, Dr. Jellinek teaches in the Heller MD/MBA program and in the Our Generation Speaks Curriculum as an Adjunct Professor of Management and Social Policy.



**ADWOA ASARE, MBA'19**, is very passionate about diversifying the talent pipeline for careers in socially responsible investing. Her current role as Program Manager of the MIINT program (MBA Impact Investing Network and Training) allows her to do just that! Ms. Asare is a systematic program builder. She successfully grew the MIINT program 22% in her first 12 months while also pivoting the program to its first ever virtual format and overseeing a curriculum redesign.

Ms. Asare has been a member of numerous inaugural fellowship programs helping to build new programs from within. Most notably are the New England Impact Investing Initiative Fellowship, Net Impact Diversity in Impact Investing Fellowship, and TPP Real Estate Development Fund Fellowship.

She recently earned her Social Impact MBA from The Heller School at Brandeis University. During her time in graduate school, she was heavily involved with entrepreneurial startup events, the career development center, and was graduation speaker and president of her MBA class. Her leadership led to the creation of new courses on impact investing and diversity in-the-workplace.

Prior to joining the staff of Bridges Impact Foundation, Ms. Asare worked at Habitat for Humanity for eight years as an Associate Director and community organizer. She is a talented program manager with an entrepreneurial spirit and spark for inclusive ideas. She is a native of Durham, North Carolina and earned her BA in Psychology from Wake Forest University. In her free time, she actively participates in social justice programs at Middle Collegiate Church and builds internationally with Habitat for Humanity.



**G. LAWRENCE ATKINS, PhD'85**, is the Chief Policy Officer for the National Partnership for Healthcare and Hospice Innovation (NPHI). He previously retired from his position as Executive Director of both the Long-Term Quality Alliance and the National MLTSS Health Plan Association in Washington, DC. He was a Board member and immediate past-President of the National Academy of Social Insurance. He served as the Staff Director of the federal Commission on Long-Term Care, which issued its final report in September 2013. Prior to that, he was Executive Director, U.S. Public Policy at the global pharmaceutical manufacturer Merck.

Dr. Atkins is a veteran of 50 years of health and social policy analysis, policy development, and legislative representation at the local, state, and federal levels. He directed Public Policy at Schering-Plough Corporation; was founder and President of Health Policy Analysts, Inc., a firm providing consultation on pharmaceutical, health benefits, and health care reimbursement issues; was Executive Director of the Corporate Health Care Coalition, an alliance of Fortune 100 companies on federal and state health reform issues; and headed a health and benefits policy practice in the Washington office of the New York law firm Winthrop, Stimson, Putnam and Roberts. During the 1990s, Dr. Atkins served on two quadrennial Social Security Advisory Commissions – 1991 as a Commission member and 1995 as a member of the Technical Panel.

During the 1980s, Dr. Atkins served on the U.S. Senate Special Committee on Aging as professional staff, Deputy Staff Director and Republican Staff Director for Chairman John Heinz (R-PA), and advised Senator Heinz as a member of the Senate Finance Committee on retirement income and health policy matters, and as a member of the 1983 National Commission on Social Security Reform. Prior to his work in the Congress, Dr. Atkins developed health and human services policy at the state and local government levels.

Dr. Atkins holds a Ph.D. from the Heller School for Social Policy and Management at Brandeis University, where he is currently a member of the Board of Advisors. He holds master's degrees from the University of Louisville and the University of Kentucky, and an undergraduate degree from Kenyon College.



**NEAL BERMAS, PhD'81**, is the founder and board chairperson of STREETS International. STREETS is an innovative and sustainable social enterprise that provides hospitality and culinary training programs for street kids, orphans, and disadvantaged youth in Vietnam. For this work, Dr. Bermas was awarded a membership to the Clinton Global Initiative in 2014. In 2015, and again in 2018, STREETS was recognized by Hyatt Hotels with a Global Community Grant Award. In 2017, Dr. Bermas received a Leadership Award from Consular Affairs of the US Department of State. In 2018, he was honored to be selected as a CNN Hero of the Year. In 2021, he received an NGO Leadership Award from the American Chamber of Commerce in Vietnam and a Mekong Tourism Award from the Ministry of Tourism and Sports of Thailand. As an independent management consultant and educator with international experience in the hospitality and tourism industry as well as with economic development. His clients have included The Walt Disney Company, Sheraton, Le Meridien Hotels, the Oneida Indian Nation and Vietcombank, Vietnam. Dr. Bermas was a Director with the worldwide consulting and financial services firm, PricewaterhouseCoopers (formerly Coopers & Lybrand).

Dr. Bermas has been quoted frequently and highlighted in publications including: The New York Times, The Wall Street Journal, CNN, The Financial Times (London), National Geographic, Gourmet Live, AsiaLife, Thanh Nien News, Cong An and Vietnam News (Vietnam), The Examiner (Australia), and Tiger Tales (Singapore).

He held dual faculty appointments at New York University's Stern School of Business and Steinhardt School of Education. He has also served on the faculty of The University of Southern California, the Institute of Culinary Education, and the Culinary Institute of America. He serves on the Board of Trustees for St. Joseph's University, New York.



**JULES BERNSTEIN '57** is a Washington, D.C.-based labor lawyer who has advocated for workers' rights for over 60 years. He has represented several of the country's largest labor unions. While counsel to the International Brotherhood of Teamsters, he helped organize the March on Washington for Jobs and Freedom in 1963. In 1970, he served as union counsel when 250,000 U.S Postal Service workers went on a "wildcat" strike. As a result, they obtained substantial wage increases, the right to collective bargaining and the first of many subsequent negotiated labor contracts. In the 1980s, he sued the Postal Service on behalf of tens of thousands of postal workers after discovering that postal employees were not being properly compensated on the job and were not being paid for work performed at home. Following years of litigation, 500,000 postal workers won retroactive wages and damages. He and his wife, Linda Lipsett, operate a "mom and pop" labor law firm, where they presently specialize in Fair Labor Standards Act litigation. At Brandeis, he established the Louis D. Brandeis Legacy

Fund for Social Justice, which supports Brandeis students, enhances campus life, and promotes the issues of social justice that the former U.S. Supreme Court justice championed throughout his life. It sponsors summer social justice internships for Brandeis students. He is also a member of the advisory board of the International Center for Ethics, Justice and Public Life, and the Heller School. He is on the board of the National Center for Jewish Film located at Brandeis. He received the Brandeis Alumni Achievement Award in 2007. After graduating from Brandeis in 1957, he earned his J.D. from the University of Chicago Law School and his LL.M. in labor law from the New York University Law School.



**Dr. ISAAC CUDJOE, MA COEX'18**, is a community organizer, social entrepreneur, and an equity strategist who has served on the alumni board since July 1, 2019. Dr. Cudjoe is a collaborative and strategic leader with demonstrated success as an active participant and in partnership with domestic and international organizations in developing countries and within the United States. He has used his training from the Young African Leaders Initiative and The African Middle Eastern Leadership fellowship to help communities inspire social change agents to do more and be more for the places they call home.

Dr. Cudjoe has a doctorate in public policy and administration. His dissertation, *Discrimination Threats for U.S.-Born Latinx During the Trump Administration*, explored whether and how U.S.-born Latinx young adults experienced discrimination during U.S. Customs and Border

Protection and U.S. Immigration and Customs Enforcement investigations, arrests, and deportation during the Trump administration. Now, Dr. Cudjoe uses system thinking to work on grassroots and local levels to help communities identify context-specific ways to transform problems in lasting ways.

Working alongside the Heller community, Dr. Cudjoe wants to help construct a more robust and equitable system for alumni relations that prioritizes belongingness. He believes that Heller's commitment to equity, inclusion, and diversity must also extend to its alumni, which begins with building bridges in all directions of our community. He wants our alumni to think of Heller's community as a warm embrace, wherein their expertise and contributions are enthusiastically welcome.



**GERBEN DEJONG, PhD'81**, FACRM is a Senior Fellow for Health Policy & Post-acute Care at the MedStar National Rehabilitation Hospital (MNRH) and serves as Professor in the Department of Rehabilitation Medicine at the Georgetown University School of Medicine in Washington, DC. He is also a Senior Advisor to, and previously was, the Founding Senior Partner with DeltaMed Partners, LLC, a Maryland-based health facility development firm working mainly in China.

Prior to rejoining MedStar NRH in late 2004, Dr. DeJong served a 2-year stint with the University of Florida as a professor in the Department of Health Services Research, Management & Policy. Previously until 2001, Dr. DeJong served for 16 years (1985-2001) as MedStar NRH's founding Director of Research and as Professor in the Department of Family Medicine at the Georgetown University School of Medicine in Washington, DC.

Dr. DeJong has conducted many multi-center clinical and health outcome studies. He is the author or co-author of nearly 300 papers on clinical interventions, health outcomes, health policy, health care financing, and post-acute care. For the last 40 years, Dr. DeJong has also tracked the American post-acute health care system and its publicly traded companies, especially their growth, development, and consolidation. He is also an avid student of health care reform and has lectured widely on the topic.

In 2006-07, Dr. DeJong served as President of the American Congress of Rehabilitation Medicine. He has served on many boards, both advisory and fiduciary. Dr. DeJong is the recipient of many awards and is a frequently invited speaker both in the United States and abroad. In 1984, he was a Fulbright Scholar in the Netherlands. In 2013, Dr. DeJong was the William Evans Visiting Fellow with the Department of Orthopaedic Surgery & Musculoskeletal Medicine at University of Otago and the Burwood Academy in Christchurch, New Zealand.



**SARAH EMOND, MPP'09** - With over 20 years of experience in the business and policy of health care, Sarah leads the strategic operations of the Institute for Clinical and Economic Review, a leading non-profit health policy research organization, as Executive Vice President and Chief Operating Officer. In that role, she is responsible for overseeing ICER's public programs, stakeholder engagement, and finances.

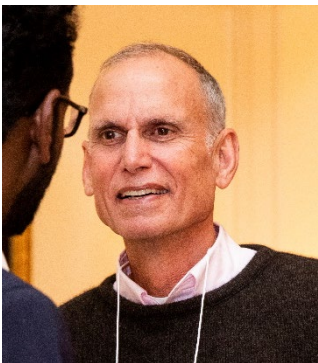


**ANITA F. HILL** is a University Professor of Social Policy, Law and Women’s Studies and Chair, Hollywood Commission for Eliminating Sexual Harassment and Advancing Equality. Professor Hill graduated from Oklahoma State University and received her J.D. from Yale Law School. Starting her career in Washington, D.C., Hill worked in private practice as well as at the Education Department and Equal Employment Opportunity Commission. In 1989, Hill, was the first African American tenured at the University of Oklahoma, College of Law. Currently, she teaches courses on gender, race, policy and law at Brandeis University and serves as counsel to the law firm of Cohen, Milstein, Sellers and Toll, where she advises on class action discrimination cases. Professor Hill leads the Hollywood Commission working with entertainment industry companies and unions to eradicate harassment and discrimination in

industry workplaces and serves on the boards of several non-profit organizations. Her latest book is *Believing: Our Thirty-Year Journey to End Gender Violence* (Viking Press 2021). As the host of *Getting Even* podcast, Professor Hill has led conversations with a range of changemakers all committed to greater equity and equality. In addition to presenting talks to audiences around the globe, she offers television and radio commentary.



**M. IHSAN KAADAN, MD, MS’16**, was born and raised in Aleppo, Syria. He graduated from the Faculty of Medicine, the University of Aleppo in 2012. After he moved to the US, Dr. Kaadan attended Brandeis University for a master’s in International Health Policy & Management, with a concentration on Health Systems Strengthening. Later, he joined the SCAD research group in the Division of Cardiology at Massachusetts General Hospital/Harvard Medical School. He is an author of many publications in cardiology, global health & health policy. A well-known scholar of public policy and public management, Mrs. Sanger has worked and published in areas including city service delivery, welfare reform, leadership, innovation, and performance management. She consults city and state government agencies on public policy and public management. She is the author of numerous books on public policy and management, including *The Welfare Marketplace: Privatization and Welfare Reform*

(Brookings Institution Press, 2003); *After the Cure: Managing AIDS and Other Public Health Crises*, written with Martin Levin (University Press of Kansas, 2000); and *Making Government Work*, written with Martin Levin (Jossey-Bass, 1994). She has been on the editorial boards of leading policy and management journals, including the *Journal of Public Policy Analysis and Management* and the *Journal of Public Administration Research and Theory*, where she was also an associate editor. She began her career as a policy analyst at Mathematica Policy Research in Princeton, a leading social policy research institution. Mrs. Sanger holds an AB with honors from Vassar College and a PhD from The Heller School at Brandeis University.



**JEANETTE C. TAKAMURA, PhD'85**, has held principal leadership positions at the national and state level and has been a higher education administrator and member of the faculty at several U.S. universities. She is currently dean emerita and professor of gerontology, social policy, and social enterprise administration at Columbia University, where she was the 17th dean and the first female leader of its School of Social Work. During her 15-year tenure as dean, she instituted multidisciplinary global, national, and statewide education, research, and service programs and collaborations that engaged academic institutions and scholars worldwide and prioritized diversity as a cross-cutting academic initiative. She was assistant secretary for aging at the U.S. Department of Health and Human Services from 1997 to 2001. There, she led the development and enactment of a modernized Older Americans Act and established the National Family Caregiver Support Program, the federal government's first

formal recognition of the significant contributions and needs of family caregivers. She also spearheaded an initiative to lay the foundation for aging policy and program coordination and collaboration across executive branch departments and agencies for the first decade of the new millennium.



Early in her career, Jeanette was a practicing social worker serving youth and families. She held senior executive positions in the Hawaii state government and faculty and administrative appointments in higher education in Hawaii and California. She has served on numerous national and international boards, commissions, and working groups, is an elected fellow of the National Academy of Social Insurance, the National Academy for Public Administration, the New York Academy of Medicine, and the Royal Society of Medicine, and has received numerous awards, among them the Lucy Stone Award from the White House for her advocacy on behalf of older women and the enactment of the National Family Caregiver Support Program. Professor Takamura was invited to serve on the Obama Transition Team, specifically for the U.S. Department of Health and Human Services. In 2009, she was honored by the Japanese Government with The Order of the Rising Sun, Gold Rays with Neck Ribbon, for contributions to the promotion of social welfare policies and programs and the status of Japanese Americans. In 2019, Advancing States, a national association for state aging departments, established the Jeanette Takamura Long Term Care Leadership Award which is given to a national leader in long term care policy and services. She is also featured in the American Society on Aging Legacy Series of interviews of twelve gerontology leaders. She was named a Social Work Pioneer by the National Association of Social Workers. In addition to her Heller PhD degree, her bachelor's degree in political science and sociology and her master's degree in social work are from the University of Hawaii-Manoa. She received special training in gerontology at Harvard Medical School-Massachusetts General Hospital and the University of Southern California Ethel Percy Andrus Gerontology Center. She is an invited featured speaker at national and international conferences on health, long term care, aging, women's issues, and higher education.

**KAREN WOLK FEINSTEIN, PhD'83**, Dr. Karen Wolk Feinstein is President and Chief Executive Officer of the Jewish Healthcare Foundation (JHF) and its three operating arms, the Pittsburgh Regional Health Initiative (PRHI), Health Careers Futures (HCF), and the Women's Health Activist Movement Global (WHAMglobal). Combined, they perform a unique mix of grantmaking, research, teaching, coaching, and project management to serve as a regional catalyst for healthcare reforms.

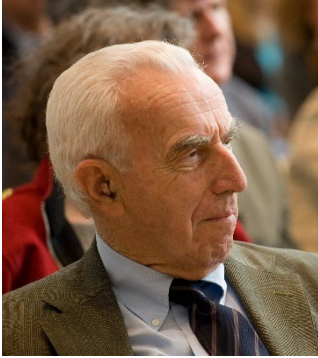
Under her leadership, JHF and PRHI have become a leading voice in patient safety, healthcare quality, and related workforce issues. When Dr. Feinstein founded PRHI, it was among the nation's first regional multi-stakeholder quality coalitions devoted simultaneously to advancing efficiency, best practices, and safety. Dr. Feinstein founded HCF to assist the region's healthcare industry in attracting, preparing, and retaining employees. WHAMglobal was established to empower women to lead efforts to advance healthcare systems that are transparent, respectful, accountable, and equitable.

Dr. Feinstein is widely regarded as a leader in healthcare quality improvement and patient safety, and she frequently presents at national and international conferences. She was a presenter at the 2016 TEDxBeaconStreet event, an independently organized Technology, Entertainment, and Design (TED) event with a global audience. Dr. Feinstein is the host of the podcast series, Up Next for Patient Safety, examining the best solutions to healthcare safety challenges. She has served on the faculties of Boston College and Carnegie Mellon University and taught at the University of Pittsburgh. Dr. Feinstein is the author of numerous regional and national publications on quality and safety. She is the editor of *Moving Beyond Repair*, which explores the conditions required to successfully apply Lean as a system-wide quality improvement philosophy. In 1998, 2002, and 2015 she was named Pittsburgher of the Year by Pittsburgh Magazine, from 2020-2022 she was recognized as a member of Pittsburgh Business Times' Power 100, and in 2021 and 2022 she was selected by City and State PA as one of Pennsylvania's Health Care Power 100.

Dr. Feinstein is a founder of the Network for Regional Health Improvement (now a part of the Civitas Networks for Health), a past President of Grantmakers In Health and Grantmakers of Western PA, and founder and co-chair of the Pennsylvania Health Funders Collaborative. She serves on many nonprofit, governmental, and for-profit boards, including the Allegheny Conference on Community Development, the Allegheny Parks Foundation, the Bon Secours Mercy Health Population and Community Health Steering Council, the Highmark Health Quality, Safety & Value Board, and the National Board of Medical Examiners Public Stakeholders Committee. She is appointed to the Commonwealth of Pennsylvania Health Research

Advisory Committee, Board of Visitors of the University of Pittsburgh's Graduate School of Public Health, UPMC Presbyterian/Shadyside Board of Directors, and the UPMC System-wide Patient Care Committee. She is a founding member of the national Women of Impact coalition and a member of the International Women's Forum (IWF) where she was the first chair of Pittsburgh's IWF chapter and co-founded their Women in Health Care Special Interest Group.

Dr. Feinstein earned her bachelor's degree in American History at Brown University, her Master of Social Work at Boston College, and her doctorate at the Heller School for Social Policy and Management at Brandeis University. Dr. Feinstein has Honorary Doctorates from Chatham and Carlow Universities.



**DAVID F. SQUIRE** has completed service as Vice Chair of the Massachusetts Development Finance Agency and Chair of Planned Giving Committee of The Boston Foundation. Currently, he is a Trustee Emeritus of Brandeis University and former Brandeis Vice President for Administration. He now serves as Vice Chair of the Emerging Technology Fund of the Commonwealth. He served as Deputy Director of the Job Corps in the Office of Economic Opportunity and as State Department Senior Advisor for Economic, Social, and Human Rights Affairs at the United States Mission to the United Nations. He was a member of several U.S. delegations to the General Assembly and the U.N. Human Rights Commission. Before his government service, he was Chief Executive Officer of Ansonia Mills, Inc., and Urban Redevelopment Commissioner in Stamford, CT. He served as Chair of the Heller Board of Overseers from 1991 to 1998.

**PROFESSOR JOSEPH K. ASSAN** is the Director of the Masters in Sustainable International Development Program, The Heller School for Social Policy and Management, at Brandeis University. Joseph holds a PhD from the University of Liverpool, UK. He is also the Associate Director for International Political Economy and Sustainable Development at the Center for Global Development and Sustainability at the Heller School for Social Policy and Management. Until his appointment at Brandeis University, Joseph was an Assistant Professor of Development Practice at Trinity College Dublin where he acted as the Associate Director of the master's in development Practice Programme which was jointly run by Trinity College Dublin and University College Dublin, Ireland. Prior to this, Dr Joseph Assan served as the Director of the International Development Program at the University of Liverpool and as a lecturer (Assistant Professor) in International Development at the University of East London, UK. Since 2018, he serves as an Editor of CASTE: A Global Journal on Social Exclusion, an open

access, peer-reviewed journal published under the auspices of the Brandeis Library. Joseph has extensive field research experience in international and sustainable development and has worked as a Project Officer with organizations such as the Global Hunger Project. He has published in numerous international peer-reviewed journals including Area Development and Policy, Foreign Affairs, Journal of Sustainable Development, Journal of International Development, and International Development Planning Review. His research examines the intersection between migration, sustainable livelihoods, environmental variability/climate change, and household well-being. He is also interested in the impact of social protection programs on human security and wellbeing within the context of poverty reduction. Over the years, Joseph has developed teaching skills and research expertise in the field of the political economy of international development with an interest in the nexus of theory, policy, and practice in Africa, Asia, and the Caribbean. Dr. Joseph Assan was invited to speak on Capitol Hill, discussing how to sustain Africa's current growth and reduce inequality. He has also participated in various international high-level fora including meetings at Brussels, Paris, Bonn, Copenhagen, Beijing, Delhi, Brookings Institution, Washington DC, focusing on global development, the USA, China, and Africa relations, livelihoods development strategies in developing countries, internal migration and displacement, and vulnerability, among others. Joseph served as the co-chair of the conference sub-theme on Migration, Borders, and Refugees for the African Studies Association. He also served on the Executive Committee of the African Specialty Group of the Association of American Geographers, a member of the Scientific Council of the Development Studies Association, UK and Ireland and a board member of the Boston Network for International Development (BNID) for several years. Joseph is currently the faculty representative on the Heller Board of Advisors and was previously a member of the Brandeis Faculty Senate.
