## **Speaker Biographies**



Dr. Stuart Altman, Sol C. Chaikin Professor of National Health Policy at The Heller School for Social Policy and

Management, Brandeis University, is an economist with five decades of experience working closely with issues of federal and state health policy within government, the private sector, and academia.

He has demonstrated leadership in health care through service on numerous government advisory boards on both the federal and state levels, including service as the Deputy Assistant Secretary for Planning and Evaluation/Health at the U.S. Department of Health Education and Welfare (HEW) from 1971 to 1976; as Chairman of the Prospective Payment Assessment Commission (ProPac) from 1984 to 1996; and in 1997 as an appointed member of the National Bipartisan Commission on the Future of Medicare. In total, Dr. Altman acted as advisor to five U.S. presidential administrations. He also served as Chair of the Institute of Medicine's Committee for the Evaluation of the Future of Nursing Campaign for Action in the 2015. In January 2016 Governor Charles Baker reappointed Dr. Altman to chair the Massachusetts Health Policy Commission as part of the states' attempt to moderate the growth in healthcare spending.

Dr. Altman has also been recognized as a leader in the health care field by Health Affairs and by Modern Healthcare, which named him in 2006 among the 30 most influential people in health policy over the previous 30 years, and which from 2003 to 2011 named him one of the top 100 most powerful people in health care. In 2014 he was awarded the Graham Life Time Achievement Award in Health Services Research by the Association of Health Administration Programs. In 2017 he was the recipient of the Champion of

Wellness Health and award by the Massachusetts Health Council and the Robert M. Ball Award for Outstanding Achievements in Social Insurance from the National Academy of Social Insurance, and in October 2018 he was presented with the Gustave O. Lienhard Award from the National Academy of Medicine. He has served on the Board of Directors of several forprofit and not-for-profit companies, and he is a member of The Institute of Medicine and chairs the Health Industry Forum at Brandeis University. He is a published author of numerous books and journal articles, the most recent, Beyond Antitrust: Health Care and Health Insurance Market Trends and the Future of Competition (2017) and Power. Politics and Universal Health Care: The Inside Story of a Century-Long Battle (2011). In addition to teaching at Brandeis, Dr. Altman has taught at Brown University and at the Graduate School of Public Policy at the University of California at Berkeley and the University of North Carolina. He served as Dean of the Heller School from 1977 to 1993 and from 2005 to 2008. He also served as interim President of Brandeis University from 1990 to 1991.



Elizabeth Fowler, Ph.D., J.D., is the Deputy Administrator and Director of the Center for Medicare and Medicaid Innovation (CMS Innovation Center). Dr. Fowler previously served as Executive Vice President of

programs at The Commonwealth Fund and Vice President for Global Health Policy at Johnson & Johnson. Liz was special assistant to President Obama on health care and economic policy at the National Economic Council. In 2008-2010, she was Chief Health Counsel to Senate Finance Committee Chair, Senator Max Baucus (D-MT), where she played a critical role developing the Senate version of the Affordable Care Act. She also played a key role drafting the 2003 Medicare Prescription Drug, Improvement and Modernization Act (MMA). Liz has over 25 years of experience in health policy and health services research. She earned her bachelor's degree from the University of Pennsylvania, a Ph.D. from the Johns Hopkins Bloomberg School of Public Health, where her research focused on risk adjustment, and a law degree (J.D.) from the University of Minnesota. She is admitted to the bar in Maryland, the District of Columbia, and the U.S. Supreme Court. Liz is a Fellow of the inaugural class of the Aspen Health Innovators Fellowship and a member of the Aspen Global Leadership Network.



**Dr. Thea James, MD,** is Vice President of Mission and Associate Chief Medical Officer at Boston Medical Center (BMC). She is the Director of BMC

Violence Intervention Advocacy Program and Associate Professor of Emergency Medicine at Boston University School of Medicine. Dr. James has primary responsibility for coordinating and maximizing BMC's relationships and strategic alliances with local, state, and national organizations to foster innovative and effective models of care that are essential for patients and communities to thrive. Integrating upstream interventions into BMC's clinical care models are critical in achieving equity and health.

Dr. James' passion is domestic and global public health. Dr. James served on the Massachusetts Board of Registration in Medicine 2009-2012 as chair of the Licensing Committee. As the Supervising Medical Officer on the Boston Disaster Medical Assistance Team under the Department of Health and Human Services, Dr. James has deployed to New York City post 9/11; New Orleans after Hurricane Katrina in 2005; Bam, Iran after the 2003 earthquake; and Port-Au-Prince, Haiti after the 2010 earthquake. Globally, she and colleagues have worked with local partners in Haiti and Africa to conduct sustainable projects. She is a member of the Board of Directors of Equal Health, an organization that supports sustainable medical and nursing education systems in Haiti.

She was awarded the Boston Public Health Commission's 2008 Mulligan Award for public service; the Suffolk County District Attorney's 2012 Role Model Award, and the Schwartz Center 2014 Compassionate Care Award. She received The Boston Business Journal Healthcare Hero Award in 2012 and 2015. The Boston Chamber of Commerce awarded Dr. James the Pinnacle Award in 2015 and she was a 2019 Massachusetts Public Health Association Health Equity Champion. In 2020, Dr. James received the American College of Emergency Medicine Lifetime Achievement Award; a History Maker Award from The History Project; and the inaugural Thea James Social Emergency Medicine Award from the American College of Emergency Physicians.

A graduate of Georgetown University School of Medicine, Dr. James trained in Emergency Medicine at Boston City Hospital, where she was a chief resident.

For twelve years Dr. James has traveled to Haiti, with colleagues and emergency medicine residents. A graduate of Georgetown University School of Medicine, James completed an emergency medicine residency at Boston City Hospital, where she was a chief resident.



**Dr. Meyers,** a boardcertified family physician, began serving as the Agency for Healthcare Research and Quality's (AHRQ) Acting Director on January 12, 2021. He leads the Agency's mission of producing evidence to make health care safer, higher quality, more accessible, equitable, and affordable, and working within the U.S. Department of Health and Human Services and with other Federal, State, and local partners to make sure that the evidence is understood and used.

Dr. Meyers joined AHRQ in 2004 and has served under four previous AHRQ directors. Since February 2020 he has been the Agency's Deputy Director where he led many of AHRQ's strategic planning activities and co-led the development of AHRQ's National Nursing Home COVID-19 Action Network.

Prior to his appointment as Deputy Director, he served as AHRQ's first chief physician and directed EvidenceNOW, AHRQ's \$110 million initiative to help primary care practices improve the heart health of their patients through quality improvement support and the implementation of new evidence. During his more than 15 years with AHRQ, Dr. Meyers has directed the Agency's Center for Primary Care, Prevention and Clinical Partnerships and established for Evidence its Center and Practice Improvement. He has also directed the Agency's Practice-Based Research Network initiatives and served as the Acting Scientific Director for the U.S. Preventive Services Task Force.

Dr. Meyers' recent publications focus on quality measurement and equity, the primary care workforce, supporting quality improvement in primary care practice, utilization of clinical preventive services, and trust in the physicianpatient relationship.

Before joining AHRQ in 2004, he practiced family medicine, including maternity care, in a community health center in southeast Washington, D.C., and directed the Georgetown University Department of Family Medicine's practice-based research network, CAPRICORN. He is a graduate of the University of Pennsylvania School of Medicine and completed his family medicine residency at Providence Hospital/Georgetown University. After residency, he completed fellowship training in primary care health policy and research in the Department of Family Medicine at Georgetown University. In 2019, he was elected a member of the National Academy of Medicine.



Mark B. McClellan, MD, PhD, is Director and Robert J. Margolis, M.D., Professor of Business, Medicine and Policy at the Margolis Center for Health Policy at Duke University. He is a physicianeconomist who focuses on quality and value in health

care, including payment reform, real-world evidence and more effective drug and device innovation. Dr. McClellan is at the center of the nation's efforts to combat the pandemic and the author of a roadmap that details the steps needed for a comprehensive COVID-19 response and safe reopening of our country. He is former administrator of the Centers for Medicare & Medicaid Services and former commissioner of the U.S. Food and Drug Administration, where he developed and implemented major reforms in health policy. Dr. McClellan is an independent director on the boards of Johnson & Johnson, Cigna, Alignment Healthcare, and PrognomIQ; co-chairs the Guiding Committee for the Health Care Payment Learning and Action Network; and serves as an advisor for Arsenal Capital Group, Blackstone Life Sciences, and MITRE.

health care payment systems and the adaptation of organizations to new payment models. He is a national expert in the field of accountable care organizations and bundled payment models. Mr. Mechanic has been principle or is co-investigator of numerous studies including the evaluation of the Blue Cross of Massachusetts Alternative Quality Contract, the most comprehensive evaluation of a commercial payer's global payment model ever completed. Mr. Mechanic has worked with numerous organizations preparing for Medicare's Bundled Payment for Care Improvement Initiative. Prior to Brandeis, Mr. Mechanic was a Senior Healthcare Analyst with Forrester Research and Senior Vice President with the Massachusetts Hospital Association (MHA). From 1988 to 1998, Mr. Mechanic was a consultant and Vice President with the Lewin Group, a Washington D.C.-based health care consulting firm. Mr. Mechanic's work has been published in The New England Journal of Medicine, JAMA and Health Affairs. He is a trustee of Atrius Health, an 800-physician multispecialty group practice in Greater Boston. Mr. Mechanic earned an MBA in finance from The Wharton School, and a BS in economics with distinction from the University of Wisconsin.



Michael Doonan, PhD, is an associate professor and Director for the Masters of Public Policy Program, Schneider Institute for Health Policy at The Heller School for Social Policy and

Management, Brandeis University. He is the Executive Director of the Massachusetts Health Policy Forum. His Ph.D. from Brandeis is both in Political Science and Health Services Research. His research and publications focus on issues related to access to health care reform, federalism, Medicaid, federal/state relations, public health and the politics and economics of health system change.

He speaks widely on state and national health care reform. He is author of American Federalism in Practice: The Formulation and Implementation of Contemporary Health Policy, published by the Brookings Institute Press in 2013. Michael worked as program specialist for the Centers for Medicare and Medicaid Services (CMS), in the area of Medicaid managed care and state health care reform. He served as a member of President Clinton's Health Care Taskforce working primarily on the Low-Income and Working Families work group, and as a member of the Taskforce Speakers Bureau. Michael also worked as a fellow for the U.S. Senate Finance Committee as they considered national reform in 1994. He began his career as a legislative aide for Senator John Kerry where he worked on health and environmental issues.
